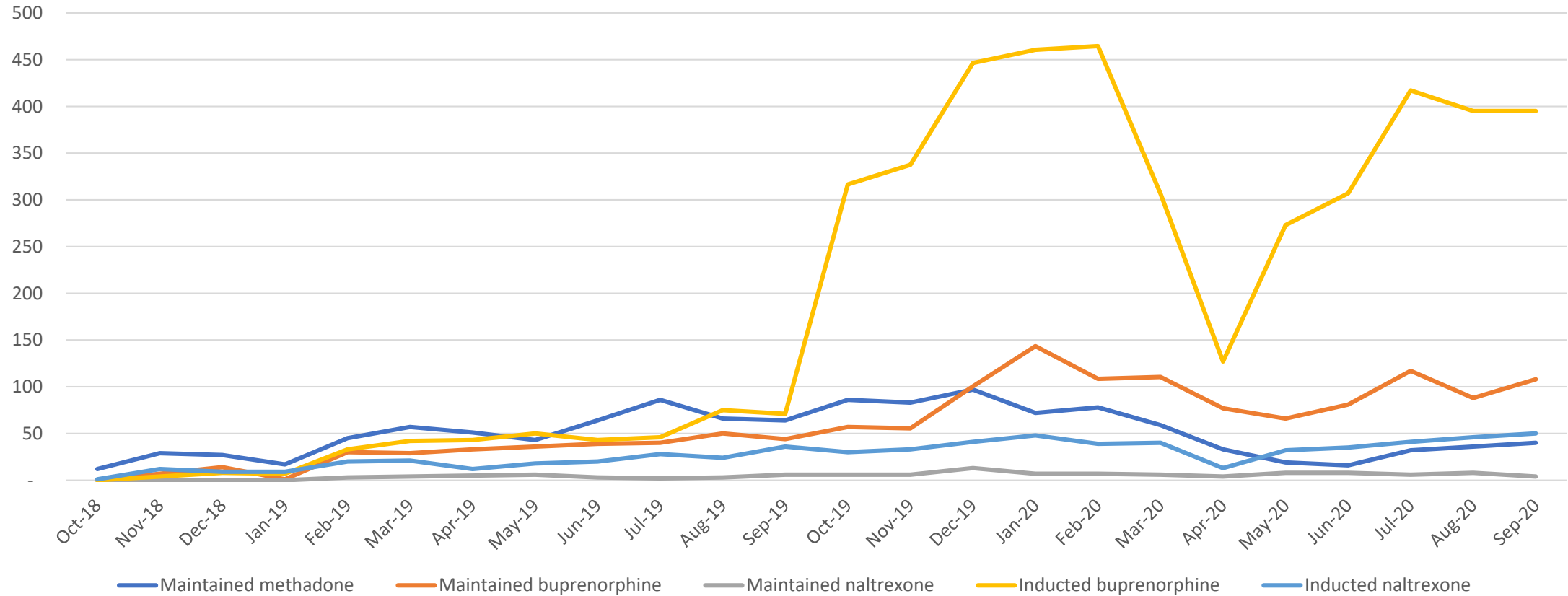

In-Jail MAT Maintenance and Inductions Cohort 1 and Cohort 2 Data October 2018-September 2020¹

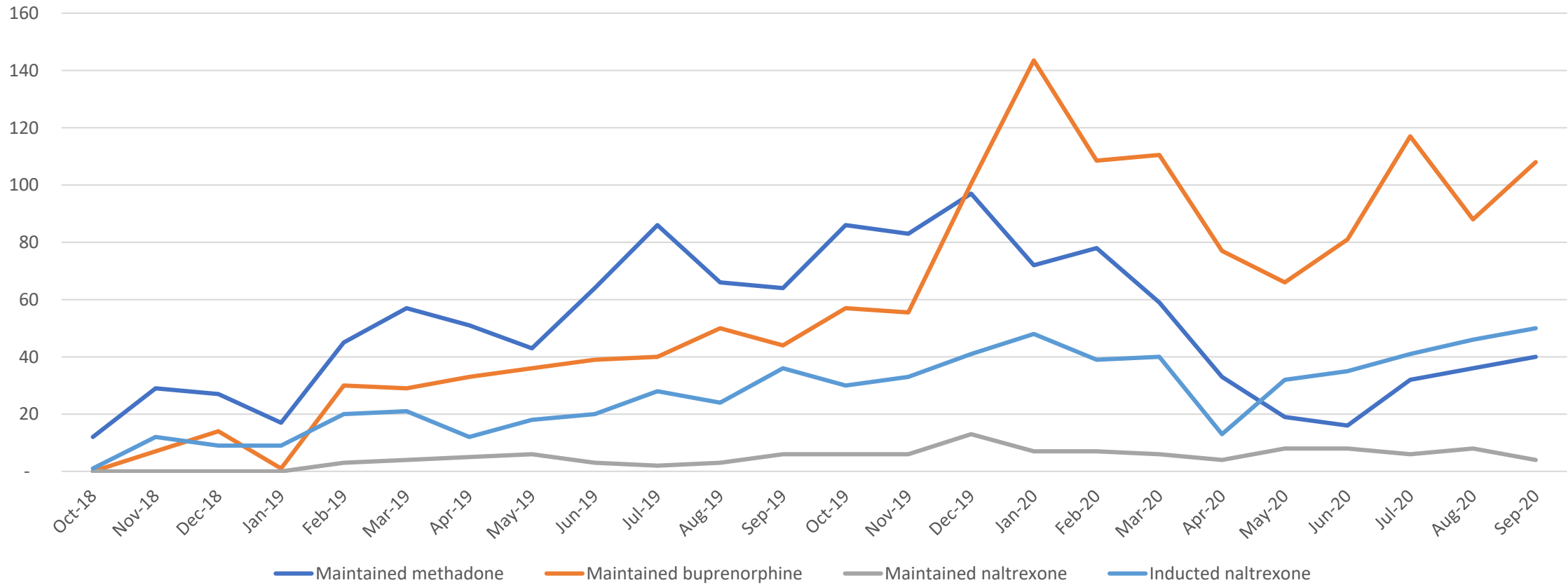

JAIL MAT TREATMENT DATA – BUPRENORPHINE INDUCTIONS REMOVED

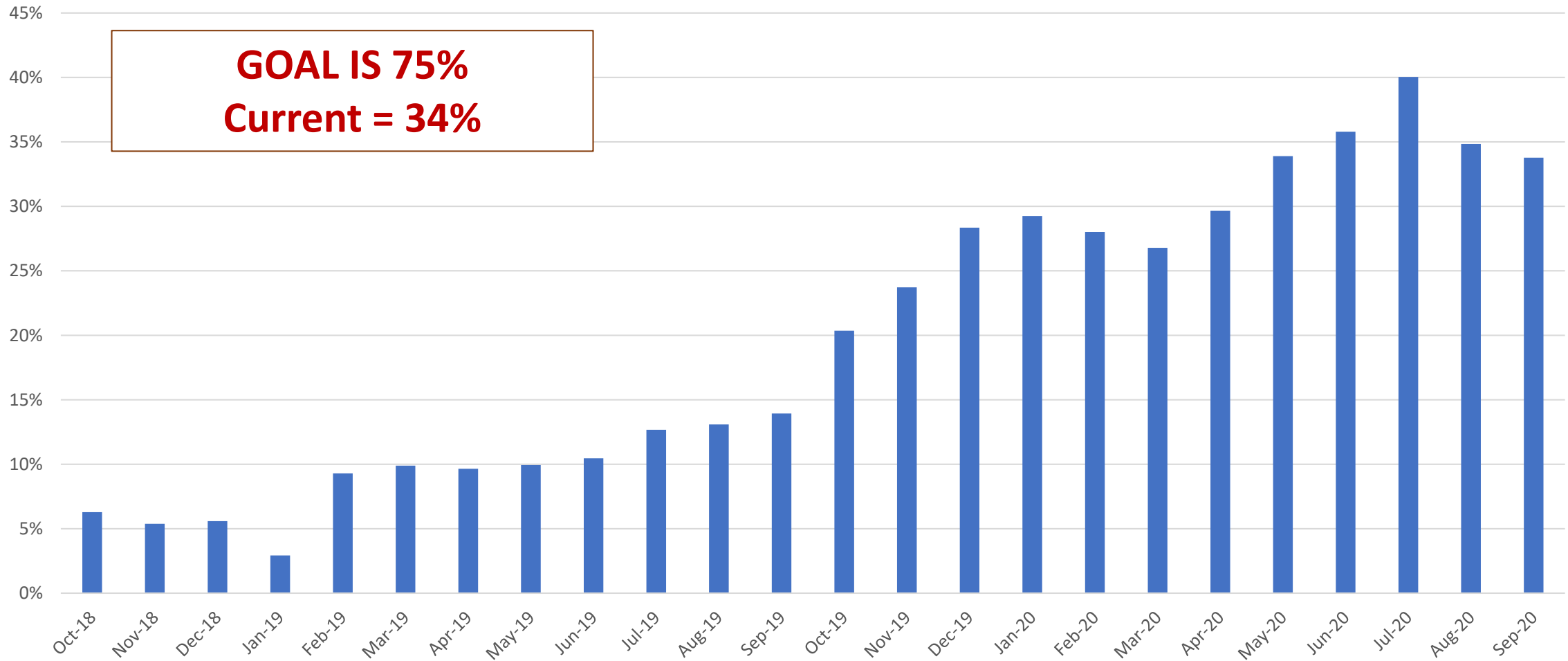
In-Jail MAT Maintenance and Inductions

JAIL MAT TREATMENT DATA – PERCENT IN WITHDRAWAL RECEIVING MAT

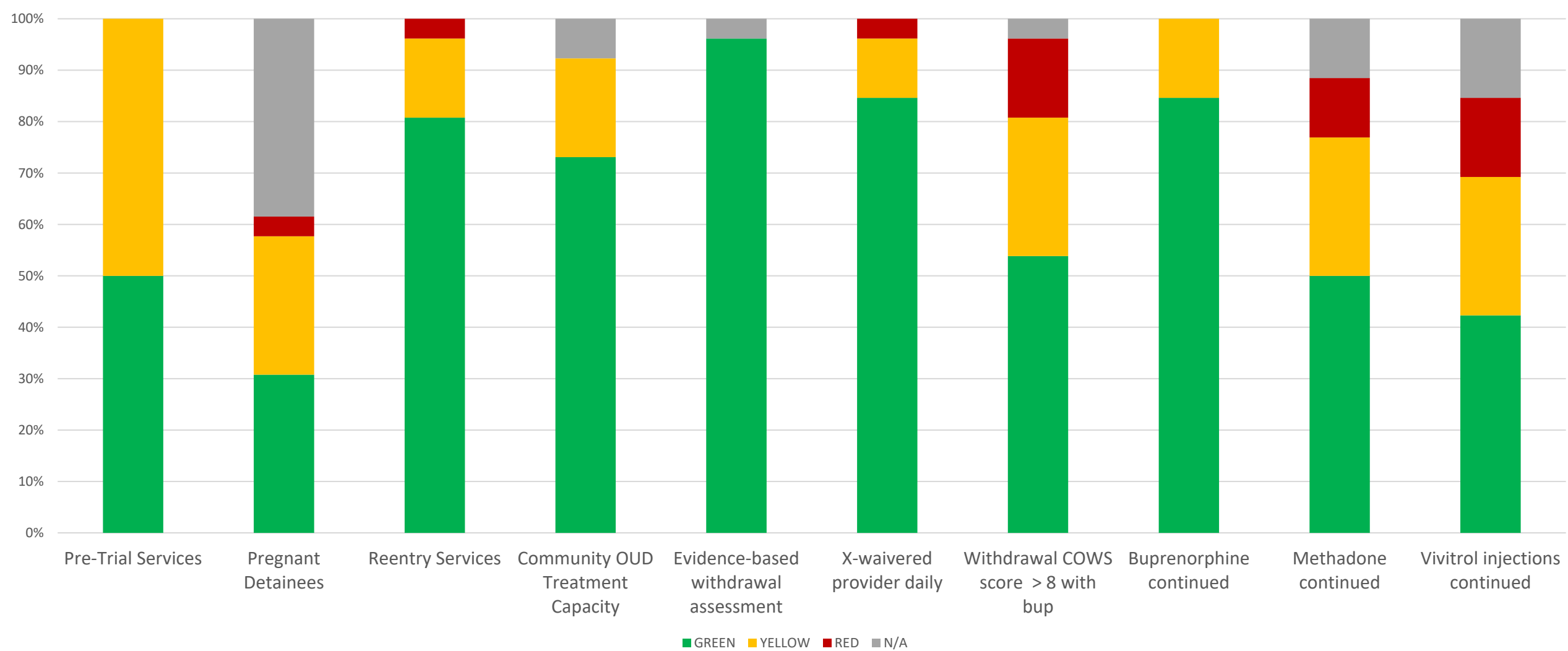
Percent of Detainees with Opioid Withdrawal Who are Treated



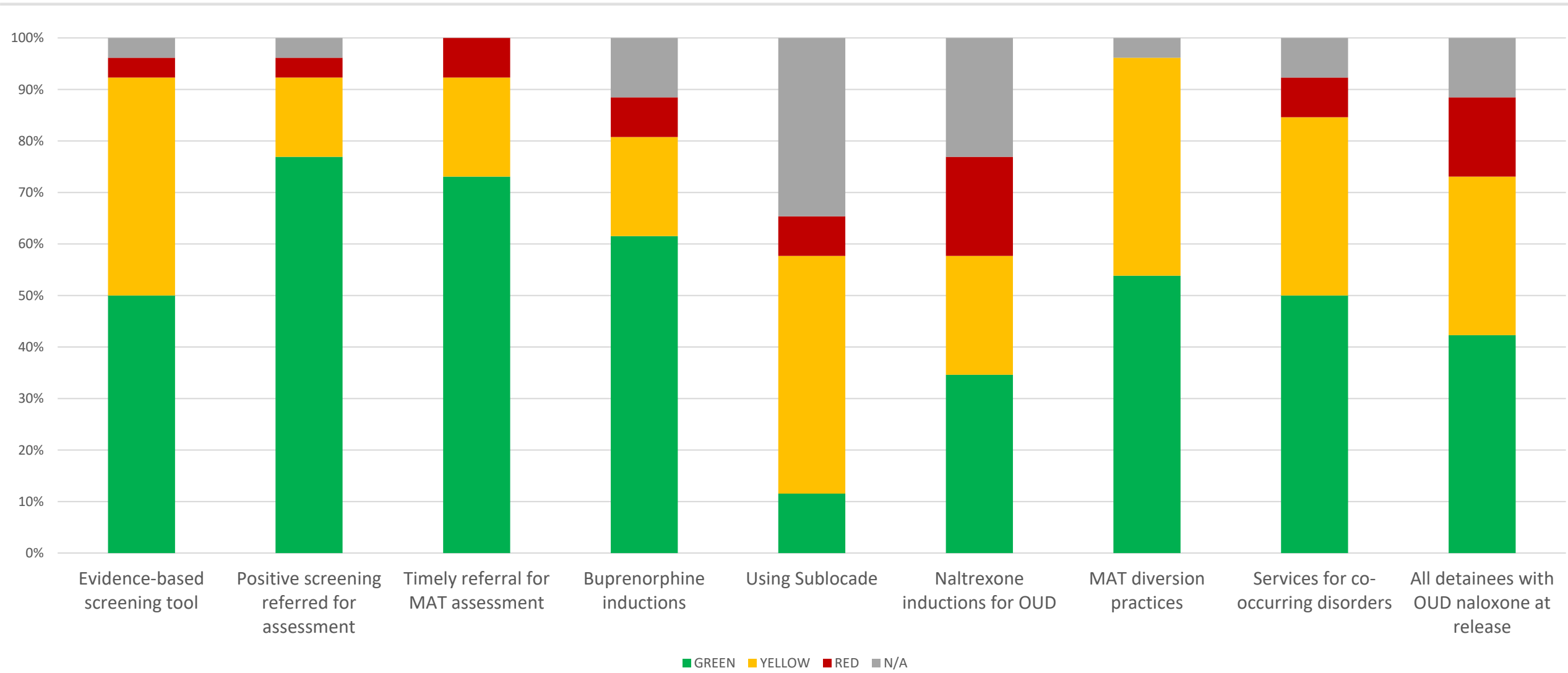
FUTURE DATA COLLECTION

- Quarterly schedule
- SOR requirements for quarterly reporting to UCLA
 - # X-waivered providers
 - # overdoses reversed with Narcan
 - Further refinements on detainee use of methamphetamine/stimulants
- Required in order to qualify for new grants

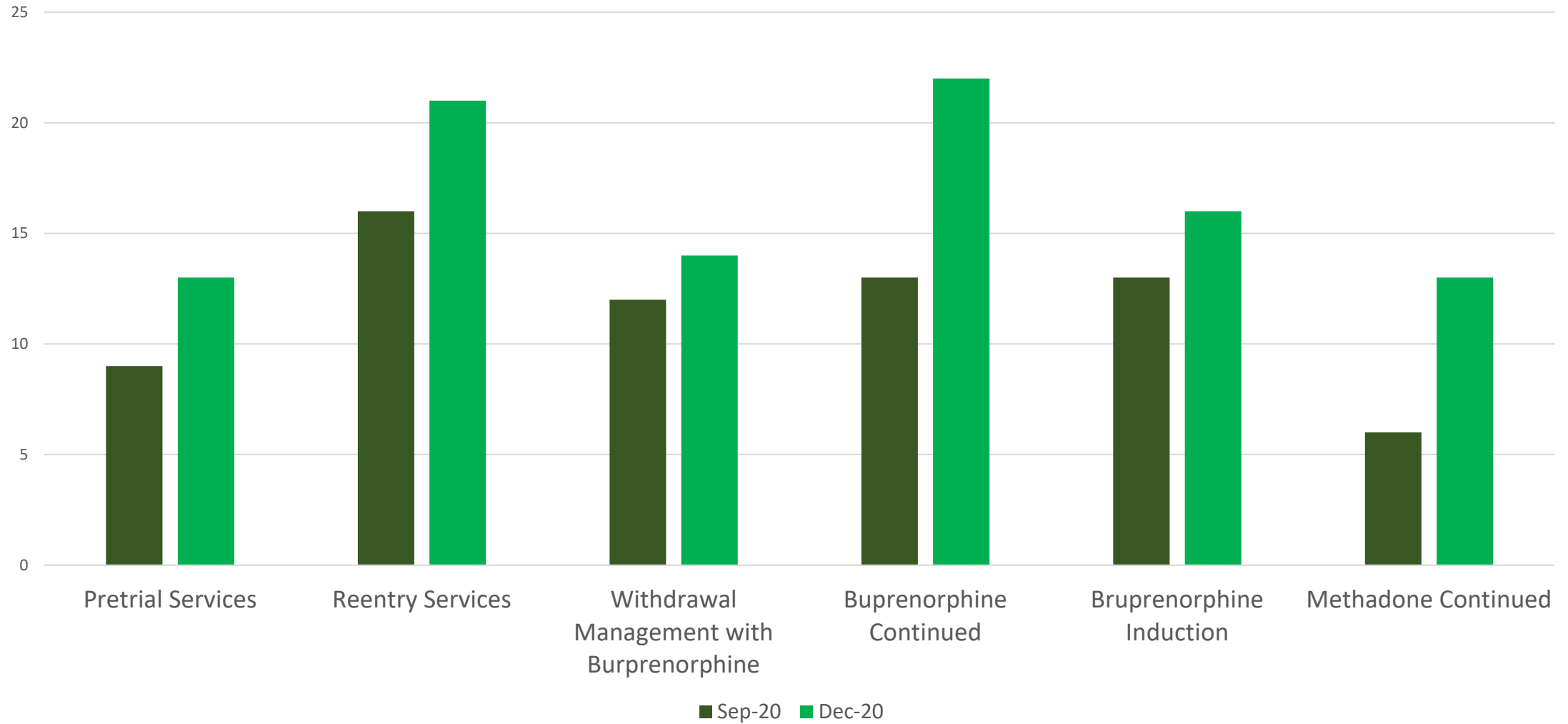
SUMMARY: TEAM STATUS BY INDICATOR (1 OF 2) DECEMBER 2020 (N=26 JAILS)



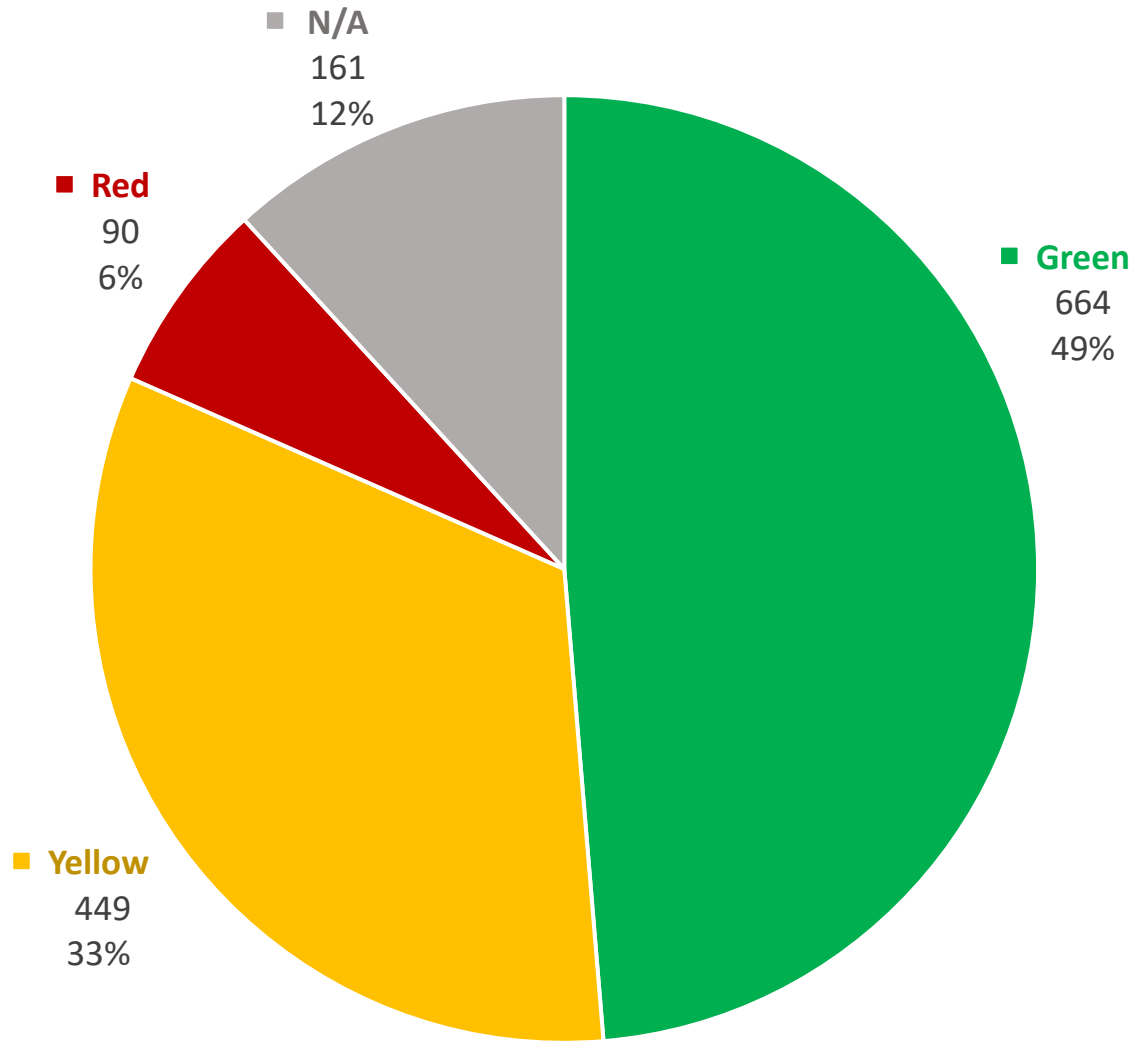
SUMMARY: TEAM STATUS BY INDICATOR (2 OF 2) DECEMBER 2020 (N=26 JAILS)



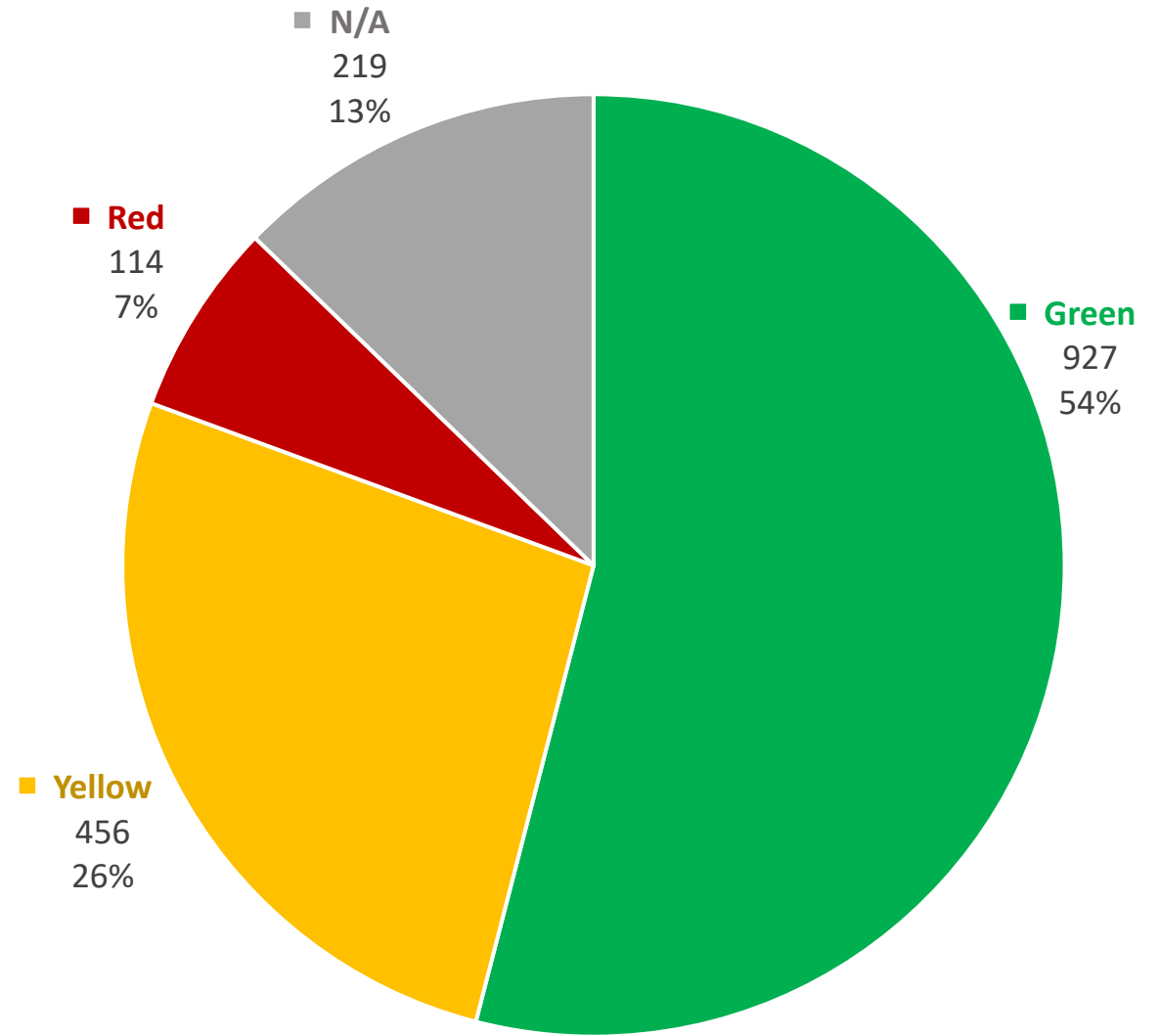
JAILS REPORTING "GREEN" STATUS (N=26 JAILS)

COUNTY TOUCHPOINTS APPLICATIONS

- Effective Child Welfare and Justice Systems for Families Impacted by Opioid and Stimulant Use
 - 14 applications
- Optimizing Community Approaches to Challenging Populations with Opioid and Stimulant Use in the Justice System
 - A) Persons with Serious Mental Illness and Addiction – 4 applications
 - B) Early Problem Substance Use/Deflection – 1 application
- Teams convene Jan 2021 – Aug 2022
- Cross-pollination of trainings, findings, models, across Jail MAT teams starting in March 2021

COHORT ONE FINAL IMPLEMENTATION GRANT REPORTING

- Grant spending date ends 12/31/20
- Funds not spent by that date
 - Moved to an account that encumbers them for explicit grant-related purpose, or
 - Returned to HMA
- Your HMA coach will be reaching out to confirm status if needed
- Final grant report format will be sent out in January
 - Simple narrative
 - Final financial report against final budget
 - Statement about intent to continue in project
- Cohort Two and 2020 Teams have until March 31, 2021 to spend funds; same rules
- No access for any teams to NEW grants until old grants are spent

NEW GRANT OPPORTUNITIES

HEALTH MANAGEMENT ASSOCIATES

Summary of Original SOR 1 Goals

Increase the use of MAT in jails and drug courts using evidence-based and emerging promising practices

Reduce stigma and increase engagement of CJ stakeholders with county SUD treatment system partners

Build data systems that capture and quantify the use of MAT and its outcomes for justice-involved individuals

New SOR 2 Goals

Build evidence-based treatment of co-occurring Serious Mental Illness and addiction for persons in the justice system

Build evidence-based treatment for persons in the justice system with Psychostimulant Use Disorder and other non-ODU substance use disorders

Begin to measure and address disparities in access to SUD treatment in your county's justice system

FUNDING PRIORITIES

- Improving withdrawal management to comply with ASAM guidelines
- Increasing naloxone distribution to persons in justice system
- Building outcome measures to consider community treatment engagement and recidivism
- Building jail and/or court-based contingency management programs for methamphetamine users (allows \$75 per year per person for rewards)
- Increasing access to MAT and stimulant assessment and treatment for persons with cooccurring SMI
- Continuation of current activities while sustainable funding is secured

GRANT CONDITIONS

- Not competitive
- Based on population size
- Rolling application period: January through June 2021
- 50% paid upon signature of MOU with HMA
- Remainder paid after satisfactory interim report
- Funding period: through June 2022
- Team will develop an action plan with dates and deliverables, along with HMA coach
- Coaching and technical assistance will follow action plan
 - More focus on process and outcomes than to date, but still flexible

ORGANIZING TO MAXIMIZE TEAM ACCOMPLISHMENTS

- SOR 2 is last opportunity to address these issues
- Goals and actions for many teams much different than earlier in project
 - Much of the in-jail work for MAT is well underway
- Good time to re-think team configuration to maximum use of this opportunity
 - Teams that have new Touchpoints awards or other grants can blend them to be most effective
 - Maybe change Team Champion
 - Maybe add members
